## **LICENSE**

## FOR THE USE OF DOCUMENTATION AND THE REFERENCE IMPLEMENTATION OF THE DCSAP PROTOCOL

- 1.1. - **1.4.** Acceptance of the offer is tantamount to acceptance of the General License Terms. If any reservations or additions to the GLT are made in the declaration, the license agreement will enter into force.
- **1.5.** The declaration of acceptance of the offer should also include the following information:
  - **1.5.1.** the name of the entity making the declaration and the persons authorized to represent it,
  - **1.5.2.** a brief description of the scope of business of the entity making the declaration,
  - **1.5.3.** contact information, including address, contact person and e-mail address.
